The Secretariat has now been informed that it will receive the Report and revised preliminary draft resolution of that Committee early next week, following which they will be transmitted to all IPU Members.

IMPORTANT

In view of the various modifications already made to the preliminary draft resolutions of the three Standing Committees and in order to facilitate the work of the Committees during the 114th Assembly, Members are asked **only to use the revised** preliminary drafts as the basis for any amendments.

Members who had earlier submitted amendments to the preliminary draft resolution and who, after reading the revised version, wish to maintain some or all of these amendments are therefore **invited to re-submit them**, following the above guidance, so that they may be circulated to all the Union's Members.

In order to facilitate the work of IPU Members, the Secretariat has the intention of sending on Friday, 21 April a document containing all the amendments received by that date. A second document with amendments received after 21 April, and within the statutory deadline of 30 April, will be circulated as delegates arrive in Nairobi to attend the 114th Assembly.
