# 1. 40<sup>th</sup> Anniversary of the Committee on the Human Rights of Parliamentarians

The Committee on the Human Rights of Parliamentarians will celebrate its 40<sup>th</sup> anniversary at the 135<sup>th</sup> IPU Assembly in Geneva. The following events will take place both to mark the occasion and to call on parliamentarians to demonstrate greater solidarity with their peers whose fundamental rights have been violated.

A two-minute **animated film** will outline the origins of the Committee, its work and objectives. It will be broadcast during the Q&A debate as well as at the entrance to the CICG throughout the Assembly in three languages (English, French and Spanish). A photo exhibition showing a series of 15 portraits of victims or former victims from across the world will be on display from **22 to 27 October** in the main entrance hall of the CICG. The exhibition will reflect the main themes of the animated film (*Never give up* and *Help us help parliamentarians under threat*).
