Revised Provisional Agenda of the Forum of Young Parliamentarians

*Monday, 14 October 2019, 2.30 – 6.30 p.m.

- 1. Adoption of the agenda**
- 2. Election of one Board member from the Asia-Pacific Group**

The Forum will elect one Board member from the Asia-Pacific Group (female) to fill that geopolitical group's seat which was not filled at the 140th IPU Assembly.
- 3. Country updates on youth participation**

The Forum will discuss recent developments in global and national youth participation. The young parliamentarians will reflect on successes and current challenges, draw conclusions and make recommendations.
- 4. Contribution to the work of the 141st Assembly**

Members of the Forum will exchange views from a youth perspective on the theme of the General Debate of the 141st Assembly.

They will be informed about the role of the IPU Committee to Promote Respect for International Humanitarian Law by its President, Ms. A. Vadai (Hungary).

Participants will also exchange views from a youth perspective on the draft resolution under consideration at the 141st Assembly, entitled *Achieving universal health coverage by 2030: The role of parliaments in ensuring the right to health*.
- 5. Update and discussion on the Forum's work plan and activities (2019–2020)**

The Forum will discuss what the IPU has done since April 2019 to support youth participation and consider the activities planned.

Participants will be briefed in particular on the results of the Sixth Global Conference of Young Parliamentarians, including the results of the first Training Hub and Mentorship Café for young MPs held during the Conference. They will be invited to make proposals on possible topics for future training sessions for young MPs.

6. Preparations for the 142nd Assembly (April 2020)

The Forum will prepare for the 142nd Assembly by discussing the items on the agenda of the IPU Standing Committees: *Parliamentary strategies to strengthen peace and security against threats and conflicts resulting from climate-related disasters and their consequences*, to be considered by the Standing Committee on Peace and International Security; and *Mainstreaming digitalization and the circular economy to achieve the SDGs, responsible consumption and production*, to be considered by the Standing Committee on Sustainable Development, Finance and Trade.

In accordance with Rule 6.1 of its Rules and Working Modalities, the Forum will appoint rapporteurs to prepare youth overview reports on the above-mentioned subject items.

7. Debate on youth policies

The World Future Council organizes an award every year to celebrate exemplary policies for future generations. This year, the Future Policy Award will put the spotlight on policies that empower young people through decent and sustainable jobs as well as civic and political participation for sustainable development and peace. The IPU, the World Future Council, the United Nations and other organizations have worked together to identify and honour the most impactful policies in empowering young people. The winners will be celebrated on Wednesday, 16 October 2019 at 3 p.m. during a special segment of the 141st IPU Assembly in Belgrade.

Participants will discuss good practices in youth policy-making. The discussion will also be an opportunity to gather the views of young parliamentarians on what makes a good youth policy and on what parliaments can do to promote policies and pass laws that advance youth empowerment.

8. Any other business
