I AM NOW VERY HAPPY TO INTRODUCE OUR KEYNOTE SPEAKERS FOR THIS SESSION. WE SHALL START WITH A VIDEO MESSAGE FROM MS. SIMA BAHOUS, EXECUTIVE DIRECTOR OF UN WOMEN.

I WOULD NOW LIKE TO PROCEED WITH OUR SECOND KEYNOTE SPEAKERS FOR THIS SESSION MR. WESSEL VAN DEN BERG, MENCARE OFFICER OF EQUIMUNDO. EQUIMUNDO HAS WORKED INTERNATIONALLY TO ENGAGE MEN AND BOYS AS ALLIES IN GENDER EQUALITY, PROMOTE HEALTHY MANHOOD AND PREVENT VIOLENCE, IN PARTNERSHIP WITH WOMEN AND GIRLS.

WE ARE VERY PLEASED HE HAVE HIM WITH US TODAY ...

MR. VAN DEN BERG, YOU HAVE THE FLOOR.

AS YOU ARE WELL AWARE, IT HAS BECOME USUAL PRACTICE AT THE IPU TO INFORM OUR GENERAL DEBATES BY BOTH A GENDER AND A YOUTH PERSPECTIVE.

I WOULD LIKE TO START BY INVITING THE PRESIDENT OF THE BUREAU OF WOMEN PARLIAMENTARIANS, MS. LESIA VASYLENKO OF UKRAINE, TO ADDRESS THIS OPENING SESSION.

NOW I INVITE THE PRESIDENT OF THE BOARD OF YOUNG PARLIAMENTARIANS, MS. SAHAR ALBAZAR OF EGYPT, TO ADDRESS US BY VIDEO MESSAGE.

LET US PROCEED.

AS YOU ALL KNOW, ITEM 2 OF THE AGENDA IS THE **CONSIDERATION OF REQUESTS FOR THE INCLUSION OF AN EMERGENCY ITEM IN THE AGENDA OF THIS ASSEMBLY**. I WOULD LIKE TO REMIND ALL DELEGATIONS THAT
WE WILL CONSIDER ITEM 2 OF THE AGENDA THIS AFTERNOON AT 5 P.M.

PLEASE ALLOW ME NOW TO MAKE A FEW ANNOUNCEMENTS IN RELATION TO THE ORGANIZATION OF OUR WORK.

FIRST OF ALL, AS IS CUSTOMARY, WE SHALL START THE LIST OF SPEAKERS IN THE GENERAL DEBATE WITH THE SEGMENT FOR PRESIDING OFFICERS OF PARLIAMENT. WE ARE GREATLY HONORED BY THE PRESENCE OF SO MANY DELEGATIONS FROM AROUND THE WORLD AT THIS IPU ASSEMBLY. I WISH TO CONFIRM THAT PROCEDURES HAVE BEEN

RESPECTED AND THAT THE ORDER OF SPEAKERS – BOTH PRESIDING OFFICERS, AS WELL AS FIRST AND SECOND SPEAKERS - HAS BEEN ESTABLISHED BY THE TRADITIONAL DRAWING OF LOTS. THIS LIST IS AVAILABLE TO DELEGATIONS IN THE HALL.

IN LIGHT OF THE HIGH ATTENDANCE AT THE ASSEMBLY, ITS STEERING COMMITTEE DECIDED THIS MORNING TO ALLOCATE SIX MINUTES AS THE TOTAL SPEAKING TIME AVAILABLE TO EACH PARLIAMENTARY DELEGATION, SEVEN MINUTES FOR DELEGATIONS LED BY SPEAKERS OF PARLIAMENT. THE YOUNG MPS WHO HAVE REGISTERED FOR THE GENERAL DEBATE WILL HAVE AN ADDITIONAL TWO MINUTES.

PERMANENT OBSERVERS WILL HAVE A MAXIMUM SPEAKING TIME OF 3 MINUTES. I WOULD LIKE TO ASK ALL DELEGATIONS TO TAKE THIS INTO ACCOUNT WHEN DELIVERING THEIR SPEECHES.

IN LIGHT OF THE COVID-RELATED MEASURES WHICH HAVE BEEN PUT IN PLACE FOR YOUR SAFETY, THE WEARING OF MASKS IS STRONGLY RECOMMENDED AT ALL TIMES, EVEN WHEN SEATED.

I ALSO WISH TO INFORM YOU THAT, AS THERE ARE STILL DELEGATIONS WHICH HAVE NOT YET REGISTERED TO SPEAK, WE WILL BE KEEPING THE LIST OF SPEAKERS OPEN UNTIL <u>TOMORROW</u>, <u>THURSDAY</u>, <u>13 OCTOBER AT</u> 12 NOON.

THE STEERING COMMITTEE THIS MORNING WAS ALSO INFORMED THAT THE FOLLOWING SPEAKERS WILL NEED TO LEAVE KIGALI EARLY (2-3 Speakers usually, their names to be communicated in the morning). WITH YOUR KIND INDULGENCE, I WOULD LIKE TO GIVE THEM THE FLOOR AT THE END OF OUR AFTERNOON SESSION TODAY AT 5 PM, RIGHT BEFORE THE VOTE ON THE EMERGENCY ITEM).

MAY I ASK THE ASSEMBLY TO APPROVE THIS DECISION?

I WOULD ALSO LIKE TO REMIND DELEGATIONS THAT THEY ARE ENTITLED TO NOMINATE ONE OF THEIR MEMBERS AS VICE-PRESIDENT OF THIS ASSEMBLY. I INVITE ALL DELEGATIONS WHO HAVE NOT YET DONE SO TO COMMUNICATE THE NAME OF THEIR CANDIDATE TO THE IPU SECRETARIAT. I WILL BE VERY PLEASED, OVER THE COMING DAYS, TO SHARE THIS PRESIDENCY WITH SOME OF THESE VICE-PRESIDENTS DURING THE GENERAL DEBATE.

FINALLY, HONORABLE DELEGATES, I WISH TO INFORM YOU THAT IN ORDER TO FACILITATE THE WORK OF THE ASSEMBLY, ON EITHER SIDE OF THE

STAGE, THERE IS AN USHER WHO WILL BE PLEASED TO TRANSMIT ANY MESSAGES YOU MAY HAVE FOR MYSELF, OR THE SECRETARIAT.

YOU HAVE BEFORE YOU THE LIST OF SPEAKERS WHO HAVE REGISTERED SO FAR FOR THE GENERAL DEBATE. FINALLY, I WISH TO REQUEST ALL DELEGATES TO STRICTLY RESPECT THE SPEAKING TIME ALLOCATED SO THAT ALL DELEGATES WHO HAVE REGISTERED TO SPEAK MAY DO SO WITHIN THE TIME AVAILABLE FOR THE GENERAL DEBATE.

THESE REQUESTS ARE TO BE FOUND IN DOCUMENT A/145/2-Inf.1 WHICH HAS ALREADY BEEN DISTRIBUTED, AND ARE AS FOLLOWS:

The following requests have been submitted:

I NOW GIVE THE FLOOR TO THE SECRETARY GENERAL TO INFORM THE ASSEMBLY ABOUT THE CURRENT SITUATION WITH REGARD TO THE DIFFERENT REQUESTS THAT HAVE BEEN SUBMITTED.

(The Secretary General explains the situation and the remaining proposals)

OUR RULES LAY DOWN THAT **ONLY ONE EMERGENCY ITEM** CAN BE ADDED TO THE AGENDA. THE ASSEMBLY WILL THEREFORE CONSIDER EACH REQUEST AND VOTE ON EACH ONE. IN ORDER TO BE TAKEN INTO CONSIDERATION, A REQUEST MUST RECEIVE A **TWO-THIRDS MAJORITY** OF THE VOTES.

MOREOVER, ONLY THE REQUEST THAT HAS OBTAINED **BOTH THAT MAJORITY AND THE HIGHEST NUMBER OF POSITIVE VOTES** WILL BE ADDED TO THE AGENDA.

WE WILL NOW PROCEED WITH THE PRESENTATIONS OF THE PROPOSALS FOR AN EMERGENCY ITEM.

I WILL NOW GIVE THE FLOOR TO ONE DELEGATE FROM EACH DELEGATION WHICH HAS PROPOSED AN EMERGENCY ITEM AND TO ONE DELEGATE - IF THERE IS ANY - WHO IS AGAINST THE ADDITION OF THE ITEM TO THE AGENDA. WE WILL HEAR THE SPONSORS OF THE ITEMS - AND ANY POSSIBLE OPPONENTS - IN SEQUENCE, BEFORE HOLDING A SINGLE VOTE BY ROLL-CALL ON THE DIFFERENT REQUESTS.

ACCORDING TO ASSEMBLY RULE 12, SPEAKERS SHOULD REFRAIN FROM GOING INTO THE SUBSTANCE OF THE ISSUES INVOLVED. THEY WILL HAVE A MAXIMUM OF THREE MINUTES EACH IN WHICH TO STATE THEIR CASE.

WE WILL NOW TAKE UP THE FIRST OF THE REQUESTS.

I CALL ON A REPRESENTATIVE OF THE DELEGATION OF TO PRESENT ITS REQUEST.

(The delegate from speaks.)

All sponsors of items for an emergency item are invited to present their proposal, with one delegation speaking against (if requested)

WE HAVE NOW HEARD ALL THE SPONSORS OF THE VARIOUS ITEMS AND WE WILL PROCEED TO THE ROLL-CALL VOTE. I CALL ON THE SECRETARY GENERAL TO EXPLAIN THE VOTING PROCEDURE.

(The Secretary General explains the procedure)

IF ALL DELEGATIONS ARE CLEAR ABOUT THE PROCEDURE, I ASK THE SECRETARIAT TO CALL THE ROLL. THIS WILL TAKE SOME TIME, AND I WOULD ASK ALL DELEGATIONS PLEASE TO BE READY TO ANNOUNCE THEIR VOTES VERY CLEARLY WHEN THEIR NAMES ARE CALLED.

(The Secretariat calls the roll.)

IF ALL DELEGATIONS HAVE VOTED, I DECLARE THE VOTE CLOSED.

HERE ARE THE RESULTS OF THE VOTES WHICH HAVE JUST BEEN HELD:

(Results will be presented to the President on separate sheets indicating the number of positive votes, negative votes and abstentions for each, and showing whether the 2/3 majority was obtained. It will also indicate whether a request has failed to fulfill the requirements of Assembly Rule 34.3 which lays down that: "When a specified majority is required, the number of affirmative votes must be equal to at least one-third of the total number of votes allocated to delegations participating effectively in the Assembly (cf. Rule 33.2))
