Ana Saldarriaga works at the World Economic Forum as the Deputy Head for the Global Shapers Foundation. She leads a team responsible for Impact Strategy, Process Optimization and Digital Engagement.

Prior to the Forum, Ana was the first Latin American woman to become the CEO/President of AIESEC, the world's largest youth-led organisation with 50,000+ members and 300+ employees. During her 7 years within AIESEC, the International Labour Organization recognized its internship model as a global example to tackle youth unemployment and develop 21st-century skills.

With an Engineering background, Ana is a Chevening Scholar with a Master's Degree in Public Administration in Engineering and Public Policy from UCL. Her research focused on the impact of artificial intelligence and new technologies on the future of work and education. She is also a Global Leadership Fellow of the World Economic Forum.

Born and raised in Medellín, she has lived in five countries and delivered events in more than 50.

Antra Bhatt is a Statistics Specialist in the Research and Data Section of UN Women. She is a key contributor in the statistical analysis for UN Women's flagship reports such as Progress of the World's Women and co-author for World Survey on the Role of Women in Development and From Insights to Action: Gender Equality in the wake of COVID-19. Before joining UN Women in 2017, Antra worked as a researcher on women's economic and social empowerment at the Tata Institute of Social Sciences in Mumbai, India and the Food and Agricultural Organization of the United Nations in Rome. She has authored a number of publications and background papers on gender inequality and its intersection with poverty, health, unpaid care, labour markets including articles in peer-reviewed academic journals, UN Women Spotlight Papers, book chapters and Op-Eds. She holds an MS in Public Policy and PhD in Economics.



Anam Parvez Butt is a Gender Justice Research Lead and Policy Advisor in the evidence team at Oxfam Great Britain where she provides intellectual leadership on research, policy influencing and data analysis on gender justice and women's rights to inform global campaigns and programmes. In particular, the focus areas of her research include social norms, gender and macroeconomic policies and ending violence against women and girls (eVAWG). She also leads on building Oxfam's capacity to deliver gender transformative research and mainstream a critical gender perspective in all research and policy. Anam has co-authored two of Oxfam's flagship inequality reports, "[Public Good or Private Wealth](#)" and "[Time to Care](#)" and has produced guidelines for effectively [integrating gender analysis in research](#).



Stefania Fabrizio is Deputy Unit Chief in the IMF's Strategy, Policy, and Review Department. Prior to joining the IMF, she was visiting professor at the University of Salamanca, Spain. Her research interests include macroeconomics, public finance and fiscal institutions, and she has worked extensively on policy issues related to the distributional implications of macroeconomic policies and reforms. Her research has been published in leading economic journals. She holds a PhD in economics from the European University Institute.



Emanuela Pozzan has more than 17 years of experience working in the Middle East, Africa and Asia on gender equality and non-discrimination in the world of work. Her educational background includes a degree in Middle Eastern Studies and a Master of Science in Development Studies at SOAS with focus on gender equality and forced migration. Her career included serving for the Italian Ministry of Foreign Affairs, NGOs, UNFPA and the ILO. She is now working in the Gender, Equality, Diversity and Inclusion Branch at the ILO HQ in the capacity of Senior Gender Equality and Non - Discrimination Specialist. She coordinates a portfolio of initiatives in the area of access to work for women, care economy, pay equity and violence and harassment in the world of work.
