# **GENERAL INFORMATION**

The 143<sup>rd</sup> Assembly and related meetings of the Inter-Parliamentary Union (IPU) will be held at the IFEMA Palacio Municipal, Av. Capital de España, 7, Madrid (Spain) from Friday 26 to Tuesday 30 November 2021

# 1. REGISTRATION

### **IPU Secretariat**

IPU Members and Observers are requested to register their delegates to the 143<sup>rd</sup> IPU Assembly via the online registration portal to be found on the official IPU website at **www.ipu.org** by *Friday, 12 November 2021 at the latest*.

# 2. LANGUAGES

English and French are the official languages of the IPU. The IPU Secretariat provides simultaneous interpretation in its four working languages (Arabic, English, French and Spanish) for the plenary sessions of the Assembly, the Governing Council, and the four Standing Committees.

Four other interpretation channels have been reserved for Chinese, Japanese, Portuguese and Russian at sittings of the Assembly and the Governing Council, and for some sittings of the Standing Committees.

# 3. HOTEL RESERVATIONS

#### 4. VISA REQUIREMENTS

In order to obtain a Spanish visa, applicants need to contact the nearest diplomatic/consular mission of the Kingdom of Spain.

Participants in the 143rd IPU Assembly shall be exempt from payment of consular fees and related charges.

### 5. ARRIVAL AND DEPARTURE

Participants are requested to provide accurate arrival and departure information for their delegation, including arrival and departure dates and times. The Hotel, Arrival and Departure Form is attached as Form 1. It can also be downloaded from www.madrid143ipu.es.

Any changes thereto should also be communicated promptly to the 143<sup>rd</sup> IPU Assembly Secretariat.

Delegations are kindly requested to arrange their own transportation from the airport to hotels.

Adolfo Suarez Madrid Barajas Airport is located 12 km away from the city center and can be reached easily, comfortably and affordably by public transport (bus, train, underground).

If you'd rather take a taxi, please note there are two different fares:

FARE 4 (flat fare to the airport) €30

Journeys originating or ending between the airport and Calle 30.

No supplements can be added to this flat rate fare which is also not eligible for the maximum rate for services booked online or by phone, provided the passenger is present at the meeting point at the agreed time.

#### FARE 3 (minimum fare to the airport)

If the journey is less than 9.5 km in distance and has not been booked online, the minimum taxi fare will be  $\in$ 20. If it is more than 9.5 km in distance (or the equivalent initial time), the price will increase in line with the corresponding fare.

### 6. TRANSPORTATION SERVICES

The Spanish Parliament will provide a shuttle service from the official hotels to all official events for the duration of the Assembly.

### 7. INFORMATION DESKS

Information desks will be open from 23 to 30 November in the lobbies of the official hotels.

### 8. SECURITY

The host Parliament will take the necessary measures to ensure the security and safety for Speakers of parliaments and other heads of delegation, delegates, invited guests, as well as their belongings, during the 143<sup>rd</sup> IPU Assembly until departure from the Kingdom of Spain.

The host Parliament will be responsible for the security and safety at the 143<sup>rd</sup> IPU Assembly venue, official hotels and social events.

Delegates are requested to wear their 143<sup>rd</sup> IPU Assembly ID badge AT ALL TIMES, both at the Assembly venue and at all official events to which they are invited.

### 9. MEDICAL SERVICE

First-aid services and medical staff will be available at the Assembly venue. All other medical services will be at the participants' own expense. Participants are advised to purchase adequate health insurance.

Persons under special medical treatment are advised to bring sufficient quantities of necessary medication. The Secretariat of the host parliament must be informed of specific medical or other indication (dietary needs, allergy, limited mobility) as soon as possible so that the necessary precautions or measures can be taken speedily.

# **10. SANITARY REQUIREMENTS**

Covid regulations in force in the Autonomous Region of Madrid are enshrined in ORDER 1244/2021 of October 1, of the Regional Ministry of Health.

These are the most relevant measures:

Mandatory use of face mask

1. Masks are mandatory from the age of 6 in the following cases:

a) Any closed public use indoor setting, or open to the public, regardless of the need to keep social distancing.

b) Outdoors when given the number of people present it is not possible to keep the minimum 1,5 meters social distancing, except as regards groups of co-habitants.

c) In air, bus or train transport, including platforms and stations, or in cable cars, as well as in public and private complementary means of transport in vehicles of up to nine places, including the driver, if the individuals in the tourism vehicle are not co-habitants.

d) In mass outdoors events, when attendants are standing or when they are seated but cannot keep the 1,5 meters social distancing, except groups of co-habitants.

The use of face mask is not mandatory in the following cases:

a) cases included in section 6.2 of Act 2/2021, of March 29, on urgent prevention, contention and coordination measures to face the health crisis caused by COVID-19.

b) when practicing sports outdoors.

c) while drinking or eating.

d) in swimming pools, when swimming and while the individual remains at a given place and is not moving, and provided that social distancing with other non-cohabitants can be observed.

e) at working places, when workers remain seated and provided that social distancing of 1,5 meters with other workers/users can be observed.

f) on occasion of judicial processes, provided that social distancing of 1,5 meters can be observed or, when the latter is not possible, if there are protection separating screens.

3. The mandatory use of face mask entails also that it must be correctly used, covering from nose to chin.

4. Masks must not include exhalation valves, except for those professional uses for which this type of mask is recommended.

Obligation to observe the indications regarding isolation and quarantine

1. Those persons considered as confirmed active infection cases and those considered as close contact of a suspicious case, whether likely or confirmed, must follow the relevant isolation or quarantine indications given by the assistance or public health bodies, and not leave their place of residence, the isolation or quarantine place in any case, except explicit authorization by the health service according to duly justified causes.

2. In case of epidemic outbreak in a social environment or increase of incidence rate in a specific geographical area, affected citizens must actively cooperate in the screening with active infection diagnostic tests to be determined by health authorities according to their nature and scope.

### **11. INSURANCE**

Participants are advised to purchase their own all-risk insurance.

# 12. PRESS SERVICE

A Press Service will operate throughout the Assembly to answer media enquiries and help facilitate press interviews. Journalists wishing to cover the Assembly must receive accreditation from the Press Service in order to receive the necessary documentation and identity badge.

# 14. OTHER USEFUL INFORMATION

#### a. Weather

The average temperature in Madrid in late November varies between +6°C and +13°C.

#### b. Electricity

The power supply in Spain is 230 volts, 50 hertz. Sockets are type F. If your electric devices operate at a lower voltage, or are equipped with different plug types, you will need a voltage converter/adapter.

#### c. Time zone

The local time is GMT+1.

#### d. Currency and banking services

The official currency is the euro (EUR) consisting of banknotes and coins. The exchange rate is *approximately:* 

1 EUR = 1.16 USD

Money can be exchanged at banks or currency exchange bureaus. Most major credit cards are widely accepted.
