# 15:15 Session 1. Public engagement - a fundamental requirement at a time of complex and multi-dimensional global challenges

Without robust public engagement, the effectiveness of governance systems overseen by national parliaments is put at risk. This can in turn compromise the need for a coordinated and multisectoral approach to the unprecedented reversal of human development gains caused by the pandemic, as well as the existential threat of climate change, and deepening inequalities and insecurities, and the rise of authoritarianism.

Panelists will explain why continuous and inclusive dialogue is a requisite for the resilience required to achieve and maintain peaceful, just and inclusive societies, and why parliaments are in general both well-placed, and well-advised, to facilitate such dialogue.
