#### Abstract

All candidatures need to be accompanied by a signed covering letter and a brief curriculum vitae (one page maximum) specifying Committee membership in parliament and familiarity with the issues covered by the IPU body for which a seat is being sought, as well as the completed contact information form (see Annex). In keeping with the provisions of the IPU Statutes and Rules, candidates should have experience and expertise, as far as possible, in the relevant areas of work, and they should be supported by their respective Parliament in carrying out their functions as IPU office holders (including in terms of being included on the national delegation to IPU Assemblies and other relevant events). Every effort should also be made to include young MPs and encourage candidatures from new Members of the IPU as well as from parliaments that do not hold other offices in the IPU.

* In accordance with Article 25.6 of the IPU Statutes, if a member of the Executive Committee ceases to be a parliamentarian, the IPU Member concerned shall appoint a substitute to serve until the next session of the Governing Council, when an election shall be held. If the newly elected member is from a different parliament to the outgoing member, s/he will serve a full term. Otherwise, the new member shall complete the term of office of his/her predecessor.

## Bureau of Women Parliamentarians

On 14 March, the Forum of Women Parliamentarians will be required to renew half of the membership of its Bureau.

Two regional representatives are to be elected from each geopolitical group, for a four-year term, to replace those regional representatives whose term expires at the 146th Assembly.

According to the Rules of the Forum of Women Parliamentarians, a retiring member of the Bureau shall not be eligible for re-election for two years.

The Forum of Women Parliamentarians will also replace one member from the Twelve Plus Group and one member from the African Group, who are no longer members of parliament, and whose term of office ends in March 2025.

In addition, the Bureau members from Belarus, Brazil, India, Jordan, Kenya, and Kuwait are completing their first two-year term and are eligible for re-election for a second term.

In accordance with the Rules of the Standing Committees:

- Members of the Bureau shall be elected for a term of two years and may be re-elected for a further period of two years.
- When a member of the Bureau has served for four consecutive years, two years must elapse before that person may again be elected to the same Bureau.
- Representatives of a Member shall not simultaneously hold more than one post as President or Vice-President of Standing Committees, or hold a post in the same body for more than four consecutive years.
- Members of a Bureau who are absent for two consecutive sessions, without a valid reason, may lose their seat on the Bureau by a decision of the corresponding Committee. In such cases, a new election will be held at the next session of the Standing Committee to fill the respective vacancy.
