The Governing Council will be called upon to approve the list of future inter-parliamentary meetings, as recommended by the Executive Committee. This includes a decision regarding the 147th IPU Assembly, which is proposed to be held in Luanda, Angola, in October 2023.

The Governing Council will consider the recommendations of the Executive Committee pertaining to parliaments that have been dissolved unconstitutionally or are in crisis and take a decision on those parliaments.
