| 11:00–11:30 | <p>and clean energy”), which is one of the Goals that will be under review during the 2023 High-level Political Forum on Sustainable Development, and on existing parliamentary practices adopted to ensure that laws/policies/national action plans are aligned with and can promote the effective implementation of the SDGs where no one is left behind.</p> <p>Part 2: Strengthening evidence use in parliaments to contribute to the effective implementation of SDG 7 in all its dimensions – environmental, social and economic</p> <p>The focus in this part will be on the importance for parliaments to exercise their oversight function in a consistent manner by: accessing high-quality, timely, disaggregated and inclusive data on the progress of SDG 7 and its interlinked Goals; building partnerships with relevant independent oversight institutes; increasing consultations with citizens; engaging in the Voluntary National Review process and providing relevant inputs. Discussions will revolve around different ways parliaments can maximize their oversight capacities regarding the implementation of SDG 7 while ensuring that no one is left behind.</p> <p><i>A panel of four speakers with diversified expertise and approaches to parliaments’ work will participate in the two segments. The focus of the first part will be on national legal frameworks that are in line with the SDGs, while the focus of the second part will be on the need for comprehensive SDG data and parliamentary oversight. Through a talk show format, invited experts will share relevant information as well as insights that could help inform and enhance parliament’s work on the SDGs. The parliamentary audience will be invited to interact with the experts, ask questions, share personal experiences and considerations.
