#### 09:40–11:15 **STRENGTHENING PARLIAMENTARY LEADERSHIP FOR THE REALIZATION OF NDCs**

COP30 marks an important turning point for the submission and implementation of revised nationally determined contributions (NDCs), while also marking the 10-year anniversary of the adoption of the Paris Agreement. This session will explore how parliaments can translate NDCs and other climate commitments into concrete domestic action, including through legislation and oversight. Parliaments will discuss opportunities for aligning national laws with NDC targets, ensuring accountability in implementation, and mobilizing finance and innovation to accelerate emissions reductions.
