The safeguards to which youth are entitled under international humanitarian law – safety, humane treatment, and protection from recruitment and use in hostilities and sexual violence – and how parliaments can help uphold these rights, will be examined. This session will explore how to ensure access to digital technologies, online safety and data privacy, protection from misinformation and disinformation, as well as a youth-friendly transitions to education, skills development and employment in an increasingly digitalized world.
