The CV should also be accompanied by a written commitment from the candidate's parliament that s/he will be supported in their work and included in future delegations to Assemblies.


[^0]:    1 Groups with 4 seats will include an equal number of men and women; Groups with 3 seats will include at least one man and one woman; Groups with 2 seats will include an equal number of men and women; Groups with 1 seat will ensure that the seat is held at least by a man and a woman over three terms.
