You can collect and review data from reliable sources on the progress of SDG implementation and its impact on citizens. You can keep parliamentarians up to date with relevant information on the opportunities and challenges that should be addressed at the local, national or international level. Furthermore, you can provide advice and information on the needs of vulnerable and marginalized groups, so that they are systematically taken into account.

I count on your strong commitment, expertise, openness to enhance parliamentary practices, and eagerness to exchange with others to identify possible strategies and practices that could be applied in the context of your own parliament to promote SDG-compliant legislation.
